- Although not strictly necessary, it is preferable that the form be handed over directly to me, as you are appointing me to sell your *Chametz* on your behalf. This process takes no more than about 10 seconds! I am happy to receive forms at any mutually convenient time.
- If you are going to be away for the duration of Pesach, the process is the same, but you must either let me know, or write this at the top of the form, so that I can adjust the form accordingly.

I, the undersigned, fully empower and authorise Rabbi Steven Dansky of Redbridge United Synagogue, to act in my place and stead, and on my behalf to sell all Chametz possessed by me (knowingly or unknowingly) as defined by the Torah and Rabbinic Law (e.g. Chametz, doubt or suspicion of Chametz and all kinds of Chametz mixtures). Also Chametz that is unfit for human food and that tends to adhere to a surface of the inside of pans, pots or cooking utensils. And to lease all places wherein the Chametz owned by me may be stored or found, especially in the premises specified below and elsewhere, up to and including the 19<sup>th</sup> of April 2019 until 10.39 am.

Rabbi Steven Dansky has the full right to sell and to lease by transactions as he deems fit and proper and for such time which he believes necessary in accordance with all detailed terms and forms as explained in the General Contract of Sale which will be signed on the instruction of Rabbi Steven Dansky or by himself. This authorisation is made as part of the contract. Also, I do hereby give the said Rabbi Steven Dansky full power and authority to appoint a proxy in his place with the full power to sell and to lease as provided herein.

The above given power is in conformity with all Torah, Rabbinical regulations and laws and also in accordance with the laws of the country, and to this I hereby affix my signature on this:
